



Winnipeg River Arts Council is pleased to announce it will be hosting the Eastman Juried Art Exhibit (EJAE) 2024. For this exhibit the judging will take place online, and an exhibit will take place on June 1st at the Great Falls Hall, 119 Carter Crescent, Great Falls, MB. We will host an opening gala on Friday, May 31st, and all the details about that will be forthcoming

Artists and artisans of all skill levels, ages 18 and older who are residents of the Eastman Region for a minimum of 2 calendar months per year, are given the opportunity to submit pictures of up to three pieces for this juried exhibition.

Ten pieces will be selected from the juried entries to participate in the Manitoba Rural and Northern Juried Art Show (MRNJA) held in Winnipeg at the MAN office at 210 Princess Street. An in-person exhibit will take place from August 1 – 24th at their gallery and the pieces will be shown online from August through December, 2024

The MRNJA show is a provincial level exhibition that celebrates the artistic achievements of artists from Manitoba's rural and northern communities. The exhibit introduces Winnipeg audiences to the artistic work generated by visual artists from beyond the perimeter (Eastman, Westman, Central, Parkland, Northern and Interlake Regions). A diverse range of media (painting, drawing, photography, sculpture, ceramics, and textiles) is exhibited. The maximum size of an art piece is 36" x 36" for display at the Manitoba Arts Network Gallery at 210 Princess Street, Winnipeg.

Pictures of the art pieces can be submitted by May 12th, 2024. Judging will take place following the submission of all pieces and will be done online, and all art will be displayed at the EJAE in June as described above.

EJAE 2024 - General Rules

1. Artists must be 18 years of age as of the date of the exhibition.
2. Artists must be a resident in the Eastman region for a minimum of two months per calendar year. The entry form should reflect this address.
3. Entry Fees – \$15 for the first piece of art, \$10 for 2nd & 3rd pieces. Limit of 3 per artist. Entry fee is non-refundable.

4. All artists must attach a digital photo of their work upon submission of their entry package to winnipegrieverarts@gmail.com

NOTE: Photos of artist work will possibly be featured in advertising and promotions related to the EJAE (see Artist Release and Waiver of Liability)

5. Each artist may enter more than one category but the limit in total is **three** pieces per artist.
6. The deadline for all entry applications is May 12th, 2024.
7. Must be an original concept & completed since July 2022: Examples of eligible work include visual arts pieces, photography, fiber arts, woodcarving, pottery & stained glass. Material that is copyrighted or from copies, paint nights, YouTube instructional videos, commercial kits or patterns will not be considered.
8. It is the artist's responsibility to enter the work into the correct category. Uncategorized or works in the wrong category, at the judges' discretion, will not be adjudicated.
9. The committee of the 2024 Eastman Juried Art Exhibition reserves the right to disqualify any work deemed to be offensive or inappropriate.
10. Awards of 1st, 2nd and 3rd place will be awarded in all categories providing there are at least 10 entries in the category. If there are fewer than 10 entries, only a 1st place award will be given.
11. Prices are established by the artist and must include 30% commission. Please state if the item is not for sale (NFS).
12. Photos of your entries can be submitted in digital form. If your artwork is 3 dimensional please take a picture of each side. Do not add watermarks or labeling to the pictures. Label your pictures (Name)-(Title of piece).jpg Ex. Smith-Tigerlily.jpg
